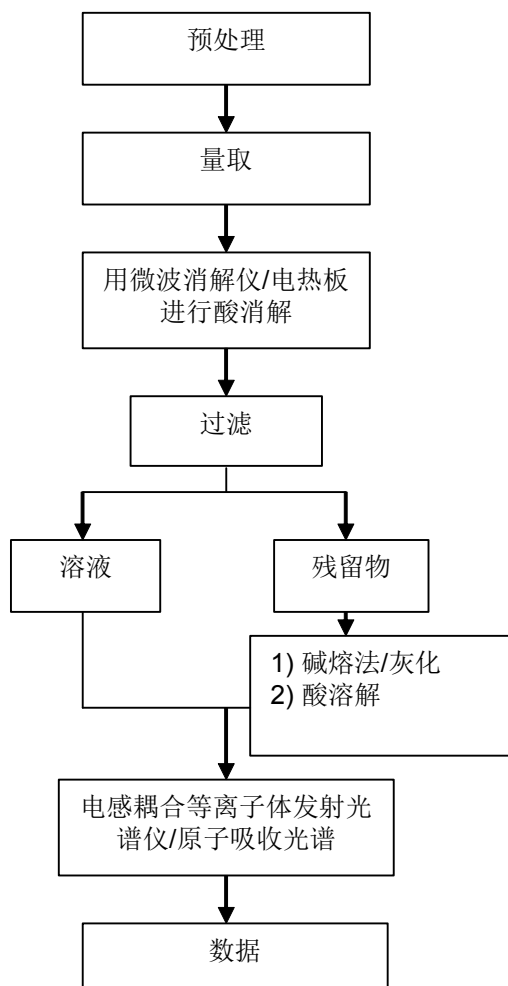

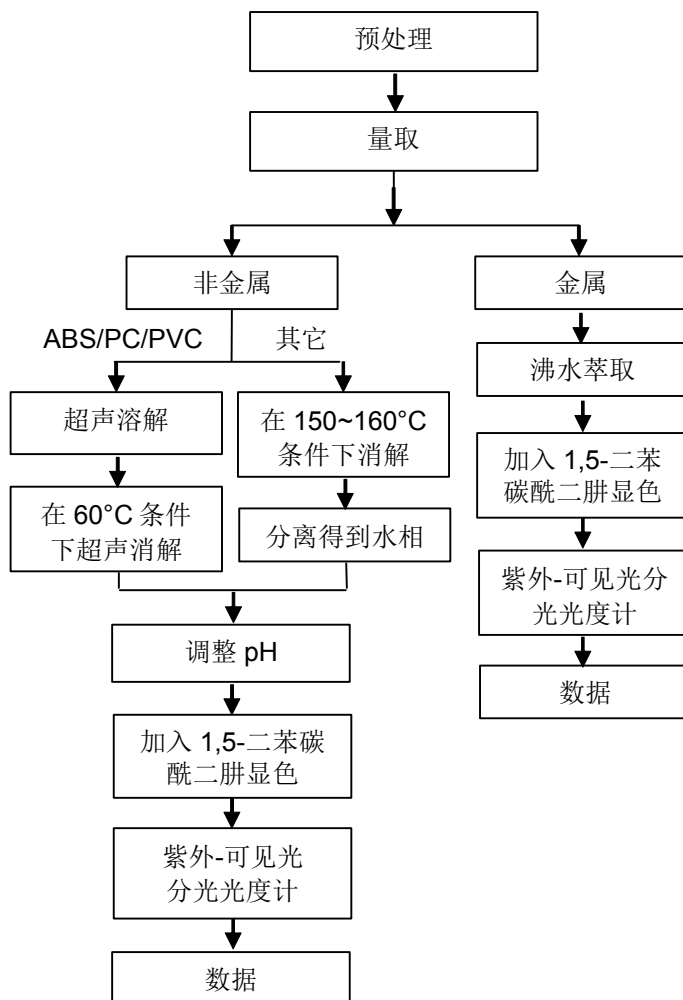

六价铬测试流程图



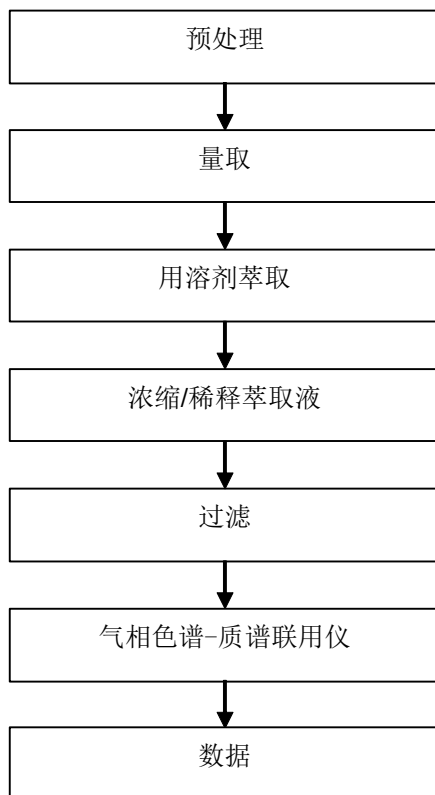

PBBs/PBDEs 测试流程图



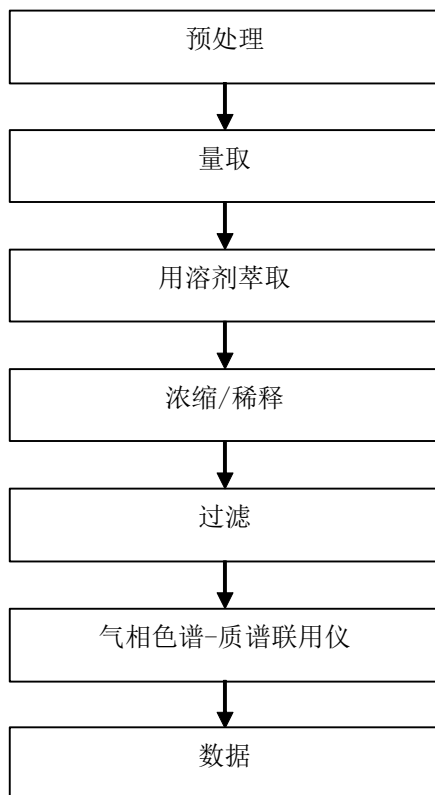
